GENERAL GUIDANCE

1. NOTICES

All communications which shall be made by the Assured or Beneficiary shall be directed in writing to the address of the intermediary given in writing in this Policy, or to the General Representative for Lloyd's Underwriters in Germany.

2. LITIGATION

Legal actions for the amount of a claim may be directed only against the General Representative. The defendant Underwriters have herein to be designated: "Lloyd's Underwriters, London, subscribing to Policy No. US172-11, represented by their General Representative for Germany."

The General Representative is empowered to represent in law all the participating Underwriters in each legal action with the right of proxy in Court proceedings. An order obtained under the legal action has effect for and against the individual Underwriters involved in the transaction. An order obtained against the General Representative subjects to execution the assets of all individual Underwriters organised in the association that are located within the territory of application of this law and are managed by the General Representative.

3. APPLICABLE LAW / JURISDICTION

German Law including German jurisdictions are applicable for the underlying insurance relationship.

4. This policy terminates on the 16.06.2012 without the need of a cancellation.
